## **Chowan Perquimans Smart Start Partnership Training Descriptions**

#### Administration of Medication in Child Care Part 1 & Part 2

Participants will learn rules and regulations of N.C. safety, medication, and sanitation requirements to assure the safety of children while in your care. Participants will learn six rights to passing medications and also completing medication administration record.

#### **Asthma Education in Child Care**

Participants will learn that every child with Asthma should have an Asthma Action Plan. Participants will learn about Asthma triggers, symptoms, treatment and living with Asthma.

#### **Bloodborne Pathogens in Child Care**

Participants will learn about infectious disease and how it is spread. The bloodborne Pathogens Standard 1910.1030 is the law that prescribes safeguards to protect workers against health hazards caused by exposure to bloodborne pathogens. This training covers the requirements of OSHA's bloodborne pathogen standard and how it applies.

## Causes of Misbehavior: Why do they act that way?

Participants will focus on the common reasons that children misbehave, a crucial first step in determining how to prevent/reduce challenging behaviors.

#### **CPR/First Aid Training**

Participants will learn how to perform CPR/First Aid. Also, learn the rules and regulations for administering both.

#### **Developmentally Appropriate Behavior**

Participants will focus on understanding when children can be expected to acquire certain social emotional skills and guides participants toward understanding, respecting and responding to developmentally appropriate behaviors.

#### **Emergency Preparedness & Response in Child Care**

Emergency Preparedness and Response (EPR) in Child Care Training provides early educators with information and tools to prepare for many types of emergencies. The EPR in Child Care Training addresses NC Child Care Rules on emergency preparedness, current best practice recommendations, and guidance on completing the online EPR Plan.

#### **How Are You? How Am I?**

Participants will learn about introducing their students to a large variety of literature and pre-literacy activities. Emotional literacy, the ability to identify, understand and respond to emotions in yourself and others in a healthy manner, is even more basic to school readiness. Examine the many benefits to children who gain a strong foundation in emotional literacy, explore simple ways in which you can foster emotional literacy in your classroom, and share some excellent resources for tools and activities teachers can incorporate into their daily classroom curriculum to make intentional teaching of emotions fun and easy.

## **ITS/SIDS**

Learn how to provide a safe sleep environment for infants in a childcare setting. Training is required every three years and within four months of hire for staff and volunteers, and family childcare home providers licensed to care for infants.

## **Playground Safety**

Outdoor play encourages movement and physical activity that is stimulating for children's development and learning. The playground safety training addresses playground safety hazards, playground supervision, maintenance, general up-keep of the outdoor area, age and developmentally appropriate playground equipment. This training offers a practical and educational interpretation of the North Carolina Child Care Commission's playground safety rules and how to conduct a playground audit.

## **Preventing Challenging Behaviors**

Participants will focus on modifications that they as a teacher can make in six key areas of the environment that will prevent and reduce conflict that leads to challenging behaviors.

## **Shaken Baby Syndrome**

Participants will learn that Shaken Baby Syndrome is a serious brain injury resulting from forcefully shaking an infant or toddler.
